REMINDER: 2023-24 NCAA National Study on Collegiate Wagering and Social Environments

In November, NCAA Research sent FedEx packages to each FAR with survey booklets, IRB materials and return shipping envelopes. To those who have not yet administered this survey, please consider doing so. ## **DIVISION I NEWS**

Dear Colleagues,

We are coming to the final stretch of what we hope was an amazing year for you and your student-athletes. We wanted to make sure you were keeping up with the latest form the NCAA Division 1 Council:

- 1. *Transfers:* The Council *adopted* legislation related to eligibility requirements for four-year college transfers which eliminates the default year in residence and establishes that a 4-4 transfer who departs their previous institution as academically eligible/in good standing and meets all progress towards degree requirements at their new institution shall be immediately eligible for competition, regardless of any prior transfers (i.e. eliminates the one-time transfer limitation). The proposal also makes other adjustments to existing transfer legislation including narrowing transfer windows for graduate transfers (must now enter by the end of their respective sport's window) and further adjusting graduate transfer legislation to better align with transfer This undergraduate legislation. legislation is *Effectively Immediately* except the transfer window for certain fall and winter sports shall remain open until May 1.
- 2. *Name, Image, Likeness* The Council adopted two proposals relating to NIL:

- a. Student-Athlete Disclosure: Proposal amends the previously adopted student-athlete disclosure requirements and specifies that a student-athlete who elects to disclose NIL deals of \$600 or more, as prescribed, may receive NIL-related assistance/services from their institution as permitted by Proposal 2024-3 (below). <u>Effective: August 1, 2024.</u>
- b. *Institutional Involvement*: Proposal allows institutions (and third-party service provides contracted by the institution) to provide NIL-related assistance and services (e.g. tax and legal services, identify and secure NIL deals, etc.) to student-athletes provided NIL-related compensation is not provided by the institution and the student-athlete is not required to accept such services and maintains authority over any agreements. *Effective Immediately*.
- 3. *Publicity of MBB Skill Instruction* The Council adopted legislation to permit skill-instruction in MBB to be publicized/conducted in public provided the activity occurs on campus or at a facility regularly used for practice/competition. *Effective Immediately.*

A few additional abbreviated highlights from NCAA DI Board of Directors meeting.

- 1. The Board formally *approved* proposed legislation relating to transfers and NIL (institutional involvement, and disclosure) as adopted outlined above.
- 2. The Board took action to remove Autonomy Conference status from the Pac-12 Conference (effective immediately) but determined that the Conference (and/or any other conference in the legislated two-year "grace period") shall maintain representation on the Council with a weighted vote representative of an FBS non-Autonomy conference. However, the Pac-12 will not maintain representation on NCAA Sport Committees (e.g. Men's/Women's Basketball Committees, Baseball Committee, etc.) during this period.
- 3. The Board reviewed and supported a plan for establishing a women's basketball performance fund that would begin with initial distribution in 2025-26 based upon performance in the 2024-25 Women's Basketball tournament. The plan will continue to be reviewed/refined in the summer/fall, with a potential full membership vote expected at NCAA Convention in January 2025.

We also ask that FARs consider nominating themselves or their peers for the FAR of the Year and Newcomer of the Year (1-3 years of experience) to be presented at the 2024 FARA

Annual Meeting in Dallas, Texas, November 14-16.

Deadlines for nominations is June 1, 2024.
